## Title: Standard Operating Procedures for Policy to monitor or prevent the conflict of interest.

- 1. It is recognized that the potential for conflict of interest will always exist but has Faith in the Steadfast IEC and its Chairperson to manage the conflict issues so that the Ultimate outcome is the protection of human subjects.
- 2. No member may participate in review, comment or approval of any activity in which he/she has a conflict of interest except to provide information as requested by the Steadfast IEC.
- 3. The Member will immediately disclose to the Chairperson of the EC any actual or potential conflict of interest that he/she may have in relation any particular proposal submitted for review by the Committee, and to abstain from any participation in discussion or recommendation in respect of such proposals.
- 4. If an applicant submitting a protocol believes that an IEC/IRB member has a Potential conflict, the investigator may request that the member be excluded from the review the protocol. The request must be in writing and addressed to the Chairperson. The request must contain evidence that substantiate the claim that a conflict exists with the member(s) in question. The Committee may elect to investigate the applicant's claim of the potential conflict.
- 5. When a member has a conflict of interest, the member should notify the Chairperson and may not participate in the IEC/IRB review or approval except to provide information requested by the Committee

6. Examples of conflict of interest cases may be any of the following: A member is involved in a potentially competing research programme - Access to funding or intellectual information may provide an unfair Competitive— advantage. Any member with conflict of interest will disclose the same before the start of the meeting and abstain from discussion and voting. The same will be documented in the minutes of the meeting.
